This privacy statement ("Privacy Statement") applies only to the www.Rasd.Finance website (or the "Website") which is provided by RASD Saudi Arabia (also referred to below as "we", "us", "our") and not to the various separate websites as per each location where RASD is present it redirects you to.

What personal information do you collect when I visit www.Rasd.Finance?

We do not require registration for access to www.Rasd.Finance, but if you participate in any of the activities or services offered by www.Rasd.Finance, we will collect the personal information that we need in order to provide you with those services, such as your name, job title, email address, employer's name, and telephone number.

We do not collect sensitive personal information from you from www.Rasd.Finance Sensitive information includes data relating to: race or ethnic origin; political opinions; religious or



other similar beliefs; physical or mental health; sexual orientation or criminal record. Where you provide sensitive personal information to us voluntarily, we will assume that we have your explicit consent to use that information in connection with the purpose for which it has been provided.

Technical Information

When you visit this website, we may collect technical information such as your IP (Internet Protocol) address, and details of the pages you visit on www.Rasd.Finance, other pages you visit on the Web, and which browser you used to view www.Rasd.Finance.

This website collects standard internet log and technical data to measure and improve the effectiveness of this website, to help diagnose problems with our server, to administer this website, to see where website traffic is coming from and to identify our users. We may also collect other information via www.Rasd.Finance, such as website usage activity and preferences, also known as demographic or profile data. When do you collect personal information through www.Rasd.Finance?

We collect personal information from you in the following circumstances:

- when you subscribe to any of our insights
- when you subscribe to any of our blogs
- when you register to attend an event
- when you enter a discussion forum

- when you submit your CV through the Careers section in our website

We collect the minimum amount of information to enable us to deal with your request. We will indicate where the provision of information is voluntary or compulsory. We would normally only request additional information to enable us to provide the most appropriate response to your request.

How do you use my personal information?

Your Rights

You have the right to request access to the personal information that you have submitted through www.Rasd.Finance, update or correct your details, opt out of receiving other information from RASD or request that your personal details are deleted from our systems at any time by e-mailing INFO@RASD.FINANCE. We will treat all such requests in accordance with applicable local law.

If you would like to opt not to receive promotional or marketing e-mail from us in the future, you may let us know by sending us an e-mail to INFO@RASD.FINANCE by mentioning “Opt-out” in the subject line and stating the e-mail address you wish to be removed from our mailing list. However, your option not to receive promotional and marketing e-mail shall not



preclude us from corresponding with you, by e-mail or otherwise, regarding your existing relationship with us.

Will you provide my information to a third party?

We may contract with other companies or individuals to deal with your enquiry or to otherwise operate this website or our business activities. We may give such companies access to your personal information in connection with those purposes on our behalf. We may also share your personal information with other member firms within the RASD network provided that this is consistent with the basis on which we have collected your personal information.

From time to time, we may disclose personal information in response to a court order, subpoena, government investigation, or as otherwise required or permitted by law.

We may, as a result of a sale, merger, consolidation, change in control, transfer of assets, reorganization or liquidation of our company (a "Reorganization Event"), transfer, sell or assign your personal information to third parties involved in the Reorganization Event.

How long do you keep my personal information?

We only keep your Information for the period required for fulfilling your request and will delete it in accordance with our data retention policies.



Is my personal information secure?

We have implemented generally accepted standards of technology and operational security to protect personal information from loss, misuse, alteration or destruction. We require all employees and principals to keep personal information confidential and only authorized personnel have access to this information.

International Transfers

You acknowledge that in order to provide services to you via www.Rasd.Finance we may need to transfer your personal information to countries that may not provide a level of protection of personal information that may be regarded as equivalent to that afforded under the European data protection legislation.

Whenever your personal information is transferred internationally, we will take appropriate steps to ensure its security and confidentiality in accordance with applicable data protection law.

Cookies

Cookies are small text files which are downloaded to your computer or mobile device when you visit a website or application. Your web browser (such as Internet Explorer, Mozilla Firefox or Google Chrome) then sends these cookies back to the website or application on



each subsequent visit so that they can recognize you and remember things like personalized details or user preferences. Cookies do not damage your system. You can reset your browser to refuse any cookie or to alert you to when a cookie is being sent.

To improve your experience and to make our service to you better we use cookies for the purposes of system administration and analytics of our website. This gives us information about the number of visitors to different parts of our website.

RASD does not share this data with third parties. Our cookies do not store sensitive information such as your name or address, they simply just enable us to see behavior on the website to help us improve your experience. How to control my cookies?

Managing cookies in my browser

Most modern browsers will allow you to:

You should be aware that any preferences will be lost if you delete cookies. This includes where you have opted out from cookies, as this requires an opt-out cookie to be set. Also, if you block cookies completely many websites will not work properly and some functionality on these websites will not work at all.

Managing analytics cookies

It is possible to opt out of having your anonymized browsing activity within websites recorded by analytics cookies. www.Rasd.Finance uses Google Analytics and you can opt out of their cookies by visiting the Google Analytics opt-out page. Please note that this will take you to the Google Analytics website and generate a 'no thanks' cookie, which will stop any further cookies being set by those third parties.
